

FACTS**WHAT DOES Minnewaska Abstract & Title, LLC DO WITH YOUR PERSONAL INFORMATION?****Why?**

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and employment information
- Mortgage rates and payments and account balances
- Account information and wire transfer instructions

When you are *no longer* our customer, we continue to share your information as described in this notice.

How?

All financial companies need to share **customers'** personal information to run their everyday business. In the section below, we list the reasons financial companies can share their **customers'** personal information; the reasons Minnewaska Abstract & Title chooses to share; and whether you can limit this sharing.

How does **Minnewaska Abstract & Title** collect my personal information?

We collect your personal information, for example, when you

- Give us contact information or show your driver's license
- Show government issued ID or provide your mortgage information
- Make a wire transfer or complete closing forms

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- Minnewaska Abstract & Title, LLC does not have any affiliates under common ownership or control.

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- Minnewaska Abstract & Title, LLC does not share with non-affiliates so they can market to you.

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- Minnewaska Abstract & Title, LLC doesn't jointly market.
